



CWCI Case Law Seminar XXVI – 2024 Update

Background: The California workers' compensation system is being constantly reshaped and redefined by case law. The growing volume of appellate case law and WCAB panel decisions, combined with the increased complexity of the issues, has made it difficult for workers' compensation professionals to keep up with all the changes and devise appropriate strategies, defenses, and responses. The 2024 program represents the 26th installment in the CWCI case law seminar series, and is designed for attorneys, claims personnel, hearing reps, and others who are responsible for administering and defending workers' compensation claims.

Important Note: A limited number of in-person seats are available on a first-come / first-served basis to those attendees wishing to enjoy the seminar alongside their colleagues. This full-day seminar will also be presented via live online video broadcast.

The program will feature a panel of workers' compensation experts from both Northern and Southern California providing an update on recent trends in decisional law and examining the practical impact that new case law will have on benefit delivery and claim adjudication.
