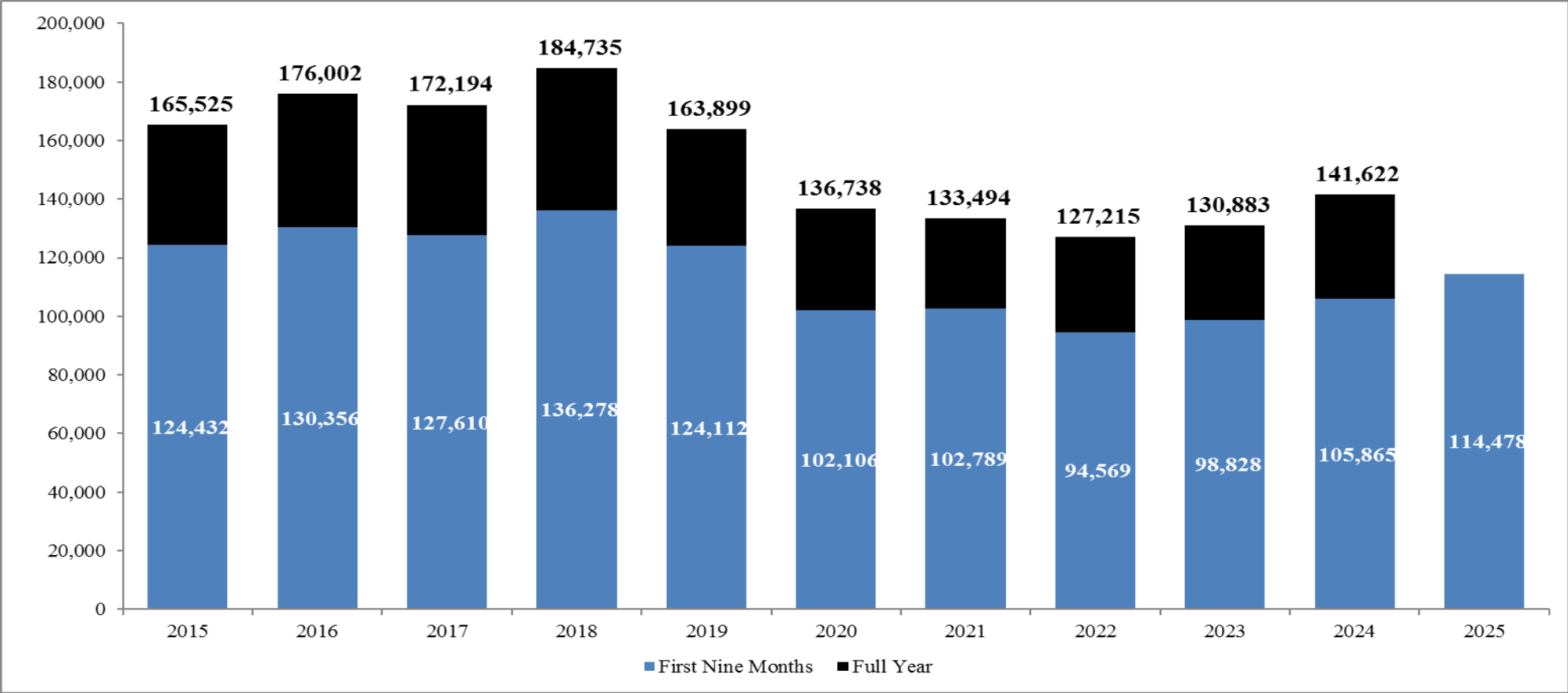
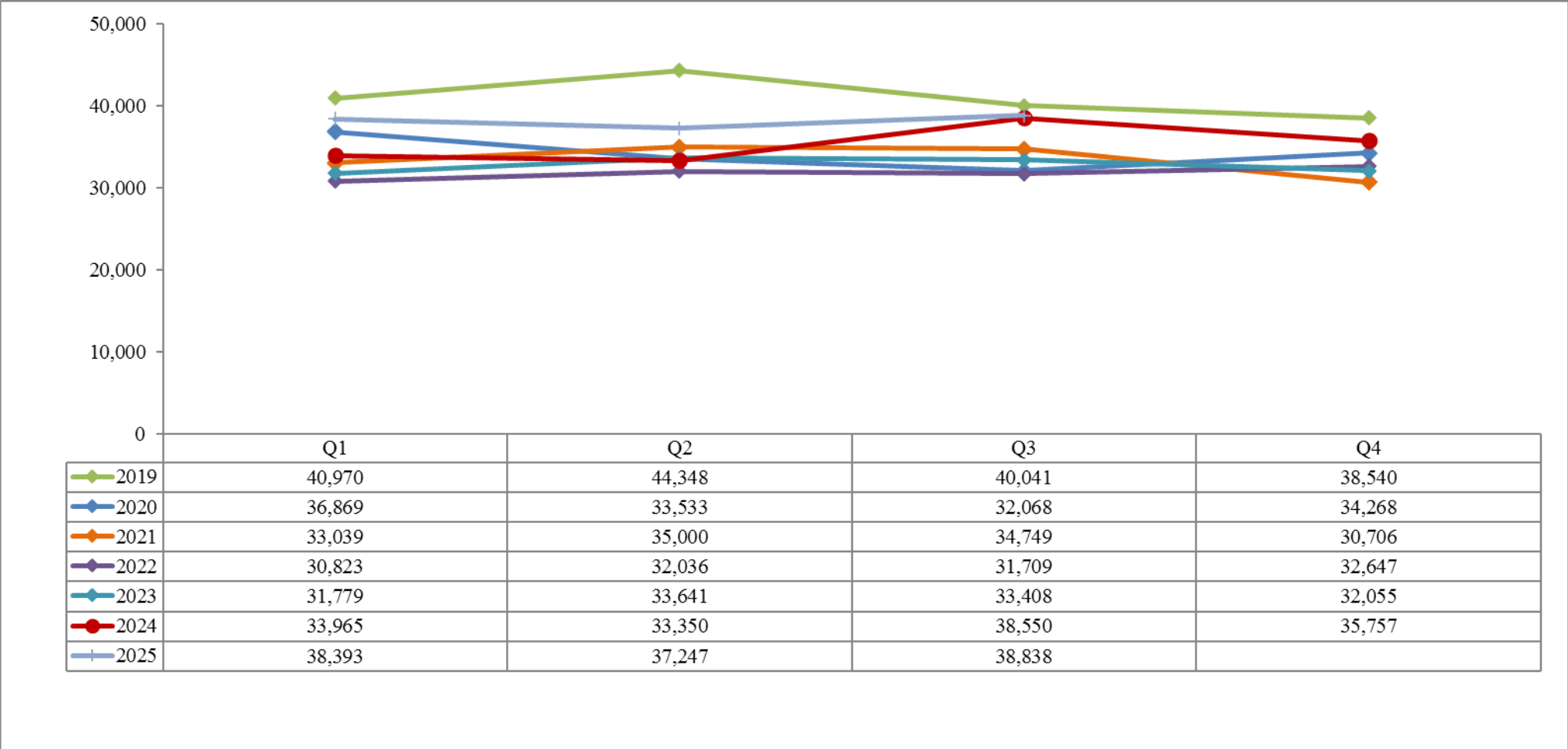


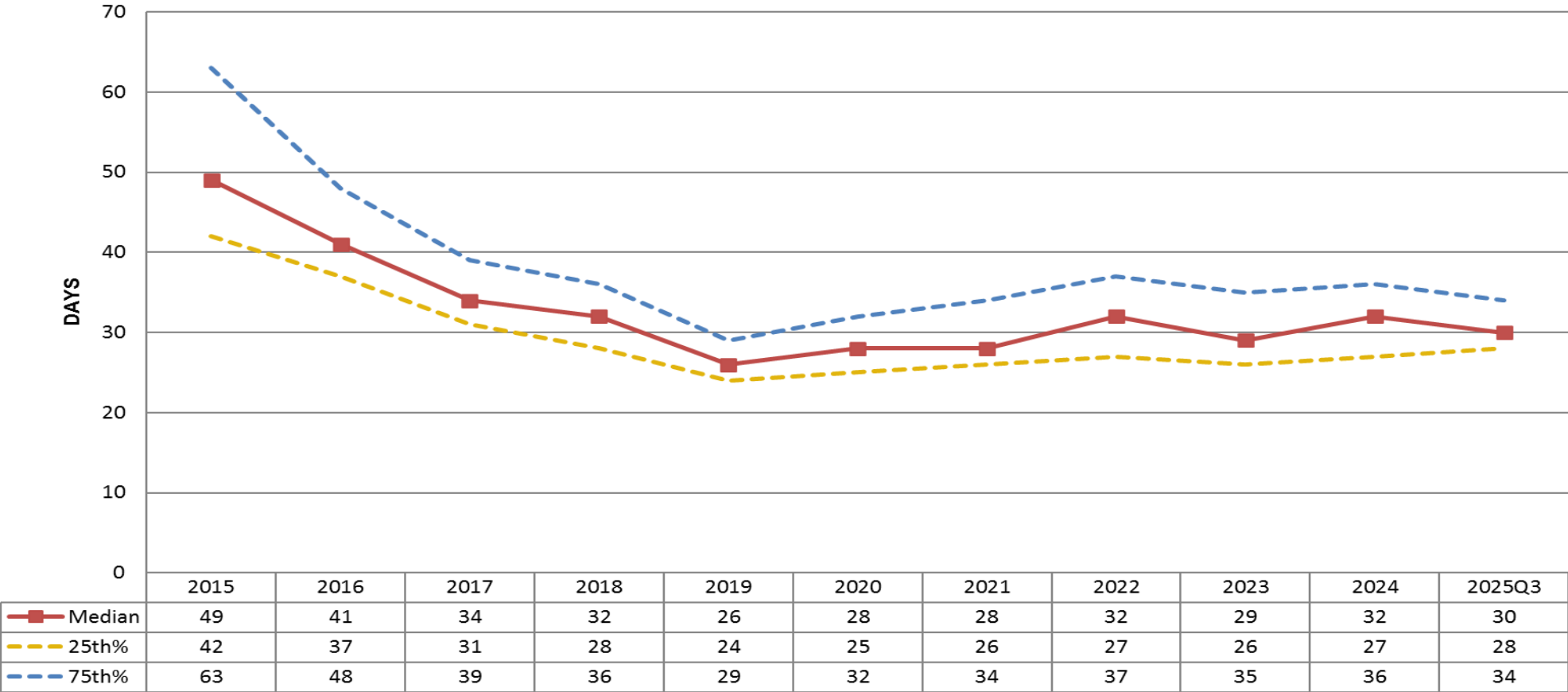
There were 114,478 IMR letters in the first nine months of 2025, an 8.1% increase from the third quarter of 2024



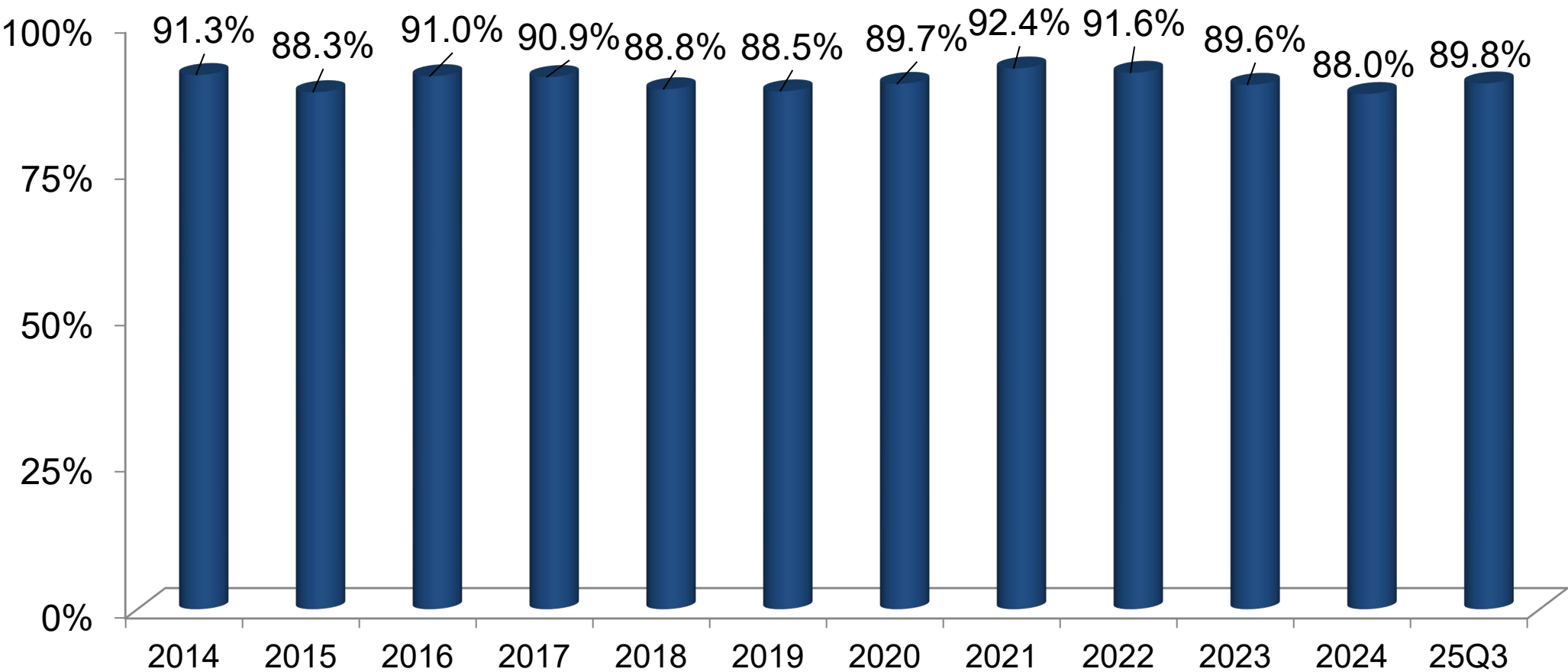
Letters By Quarter
